ORIGIN — A meeting to organize a Library Association was held in Detroit, September 1, 1891, in response to a call sent out by several librarians in the state. About forty persons were present, twentynine of them actively engaged in library work, and a number of the others trustees of libraries. A good degree of enthusiasm pervaded the meeting; a simple constitution was adopted, and officers for one year were elected. The growth and influeace of the association have been steadily increasing ever since.

OBJECT — The object of the association is to advance library interests in the state. This is accomplished in a number of ways. I. Meetings are held in different towns, and the presence of an organized, enthusiastic body calls attention to the work to be accomplished by libraries. II. Questions of library management and economy are discussed, and the interchange of experience and ideas is beneficial to all employed in library work. III. At each meeting, several hours are devoted to visiting a library, and studying the methods in use. IV. Trustees, library committees and all persons interested in libraries are welcomed as members, and the needs of library work from the standpoint of the reader are considered.

II. Object.

Its object shall be to promote the library interests of the state of Michigan.

III. Members.

Any person interested in advancing its object may become a member of this association by vote of the Executive Board and payment to the Treasurer of the annual assessment.

IV. Officers.

The officers of the association shall consist of a President, two Vice-Presidents, a Secretary and a Treasurer. who shall be elected by ballot at the annual meeting. and who shall constitute the Executive Board, which shall have power to act for the association in intervals between its meetings. V. Meetings.

There shall be one or more meetings each year, the time and place of which shall be fixed by the association or by the executive board, and ample notice of such time and place shall be furnished to each member. and a same another and a more state

VI. Dues and Debts.

The annual assessment shall be fifty cents. No officer, committee, or member of the association shall incur any expense in its name, nor shall the Treasurer make any payment from its funds, unless authorized so to do by vote of the executive board. . VII. Amendments.

This constitution may be amended at any meeting, notice of the proposed change having been previously furnished each member in the call for the meeting.
